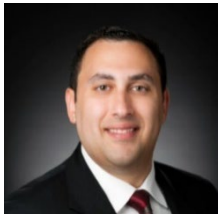

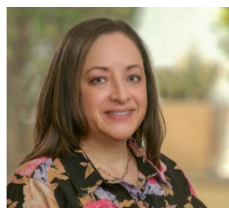


Jessica DiLeo, PharmD, BCACP, BCGP

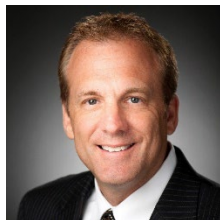

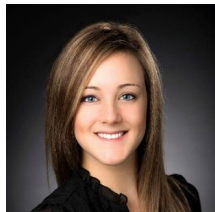

Mr. Greenhalgh earned a Bachelor of Science in Pharmacy from Temple University and holds the Registered Pharmacist designation.



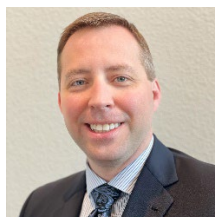
Sarah R. Haines, MSW, MBA

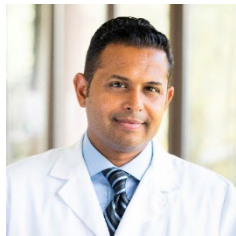
